Yamhill SWCD Definitions: "A" List Weeds – a weed of known economic importance which occurs in the county in small enough infestations to make eradication/ containment possible; or is not yet known to occur, but its presence in neighboring areas makes future occurrence in the county seem imminent.

"B" List Weeds – a weed of economic importance, which is regionally abundant, and needs to be controlled where found.

"T" List Weeds – A priority noxious weed that will receive the highest priority for treatment. The SWCD and partners will attempt to control where found through containment or eradication.
